



ESTABLISHMENTS' STATUS

At EAEVE Annual General Assembly held in Naples 1998, the members agreed unanimously that at the end of the second cycle of visits a list should be made available classifying each institution in Europe in one of the following categories:

- **Visited and approved establishments** found to meet the requirements of the EU Veterinary Training Directives, as interpreted in the “Guidelines, requirements and main indicators” section of the “Standard Operating Procedures” document (year of the original visit-year of the next visit)
- **Visited and accredited establishments** found to meet the requirements of both stage I and stage II
- **Visited and conditionally approved establishments** failing to meet no more than two of the requirements set out in the Directives (so called category I deficiencies) – which are deemed rectifiable within 2 years
- **Visited establishments** failing to meet more than 2 of the requirements set out in the Directives (category I deficiencies)
- **With pending visitation**
- **Not visited establishments** (not yet applied for visitation)
