EAEVE Veterinary Education Establishments' Status

This table lists the EAEVE membership status and the outcome status of the Veterinary Education Establishments (VEEs) after following the European System of Evaluation of Veterinary Training (ESEVT).

In line with the EAEVE Statutes, the Association is composed of Full members, Candidate members and Associates:

- **Full members** are VEEs located in Europe (as defined by the Council of Europe) which have completed an ESEVT Full Visitation;
- Candidate members are VEEs located in Europe (as defined by the Council of Europe) which are either entering the ESEVT evaluation process
 or which have been reclassified for not fully following the ESEVT evaluation process;
- **Associates** are VEEs from outside Europe which follow the ESEVT evaluation process.

In line with the ESEVT Standard Operating Procedure (https://www.eaeve.org/esevt/sop), the decision by ECOVE on the outcome status of the VEEs after following the ESEVT can be one of the following:

- -) Accreditation or Approval in case of no Major Deficiency;
- -) **Pending Accreditation** in case of 1 or several Major Deficiencies (under SOP 2019 as amended in September 2021);
- -) **Non-Accreditation** or **Non-Approval** in case of several Major Deficiencies (under SOP versions before 2016 and 2019) and by decision of ECOVE following a Re-visitation or end of granted status;
- -) Conditional Accreditation refers to VEEs with 1 single Major Deficiency (under reference with previous versions of the SOP 2016 and 2019).
