



## FVE-EAEVE Press-release

### **Top level Quality Assurance for Education in Veterinary Medicine in Europe**

*Veterinarians fulfil important tasks. They care for the health and welfare of animals and for public health. High quality education is essential for every qualified veterinarian.*

*The European Association for Quality Assurance in Higher Education (ENQA) has formally recognised the quality assurance system for veterinary education in Europe. This system, which was established by the European Veterinary Schools and the European Veterinary Profession, is the first profession-specific European quality system that is accredited by ENQA<sup>1</sup>. Veterinary education has reached a front position in quality assurance. Animals and People can rely on it!*

The European Association for Quality Assurance in Higher Education ([ENQA](#)) formally acknowledged that "the European Association of Establishments for Veterinary Education ([EAEVE](#)) provides 'quality' and quality assurance in Veterinary Medicine". EAEVE fulfils its mission by reaching compliance with the Standards and Guidelines for Quality Assurance in the European Higher Education Area (ESG 2015) while fully conforming to the EU Directives.

EAEVE together with the Federation of Veterinarians of Europe ([FVE](#)) have created a professional peer evaluation system for the "Accreditation of Veterinary Education Establishments", which runs for over 30 years. The European System of Evaluation of Veterinary Training ([ESEVT](#)) has been developed to ensure that veterinary curricula comply with the requirements set in the European Union legislation.

The President of EAEVE, Prof Dr Ana Bravo expresses her great pride on the achievement. "Over 30 years of continuous efforts and commitment are crowned by the acknowledgment of this prestigious European accreditor agency." "It is indisputable that a periodic external review fosters EAEVE to improve its quality assessment methodologies for veterinary education, a precondition for ensuring trust in each Establishments' educational system and in the qualification they provide" she adds.

The President of the Federation of Veterinarians of Europe, Dr Rafael Laguens, highlights that recognition of qualifications in the EU must go hand in hand with assuring the value of the underlying education programmes. "Veterinary schools play a key role in preparing future veterinarians. They prepare veterinarians to be the gatekeepers for health and welfare of animals as well as for public health. Dr Laguens reiterates the need for the European Commission to endorse the
